

**THE CHILL JACKPOT SWEEPSTAKES
OFFICIAL RULES**

SWEEPSTAKES ENTRY PERIODS: The Chill Jackpot Sweepstakes (the “Sweepstakes”) begins at 12:00:01 AM Eastern Time (“ET”) on Wednesday, April 15, 2026 and ends at 11:59:59 PM ET on Sunday, January 31, 2027 (the “Sweepstakes Period”). Within the Sweepstakes Period, there are eight (8) Entry Periods (each, an “Entry Period”) and eight (8) corresponding Random Drawings (each, a “Drawing”) as defined in the “Entry Periods & Drawings Schedule” below. Non-winning entries for an Entry Period will roll over to subsequent Entry Periods’ First Prize drawings, if applicable. Grand Prize winners will be selected in a series of drawings as detailed in the Drawings section below. Sponsor’s computer is the official timekeeping device for this Sweepstakes.

ELIGIBILITY: The Sweepstakes is open to legal residents of the United States, including the District of Columbia, who are age 18 or older and at least the age of majority in their state of primary residence at the time of entry. Void in Puerto Rico, Guam, the U.S. Virgin Islands, outside the U.S., and wherever else prohibited by law. Employees of Chillhouse LLC (the "Sponsor"), Votigo, Inc. (the “Sweepstakes Administrator”) and their respective subsidiaries, affiliates, advertising and promotion agencies, and the immediate family members (spouses, parents, children, and siblings and their spouses) of, and/or those living in the same household of each, are

not eligible to enter. Sweepstakes is subject to all applicable federal, state and local laws and regulations.

HOW TO ENTER: There are two (2) ways to enter.

Method #1: Purchase Entry. During an Entry Period, participants may make a purchase of a Chillhouse brand product online or in-store at a CVS, Target, Walmart or other authorized Chillhouse retailers and save your purchase receipt (the "Purchase Receipt"). Participants must then visit www.chillhouse.com/win and follow all entry instructions to upload an image of the Purchase Receipt, complete the entry form in its entirety and submit to receive one (1) entry into the Sweepstakes (the "Purchase Entry"). Each Purchase Receipt may only be used a single time; subsequent Purchase Entries must be submitted with a different, valid Purchase Receipt. Purchase Receipts dated outside of an Entry Period are not eligible. Entrants are subject to all notices posted online including but not limited to the Sponsor's Privacy Policy, which can be found at <https://chillhouse.com/pages/privacy-policy>.

Method #2: Free, Alternate Method of Entry ("AMOE") / Mail-in Entry. All Entries become the property of the Sponsor and will not be acknowledged or returned.

PRIZES/APPROXIMATE RETAIL VALUE ("ARV")/ODDS:

Summer Chill Grand Prizes: There are five (5) Summer Chill Grand Prizes available to be won. Each Summer Chill Grand Prize consists of a Chill in the City trip package for two (2) people, Grand Prize winner and one (1) guest (the "Guest"), to New York, NY on a date to be determined by Sponsor in September or October of 2026 (to be announced at the time of winner notification). Grand Prize trip package includes:

- Round-trip, coach-class air-transportation for Summer Chill Grand Prize winner and Guest

- to New York, NY from a major airport within the 50 United States nearest the winner's residence as determined by Sponsor;
- Two (2) nights hotel accommodations based on a single room with double occupancy at a hotel of Sponsor's choice;

 - One (1) dinner for winner and Guest;
 - One (1) gifting and entertainment package (contents/details to be determined by Sponsor); and
 - One (1) spa service at Chillhouse Soho up to a maximum value of \$500 each for winner and Guest.

The ARV of Summer Chill Grand Prize: \$3,900 each.

Holiday Chill Grand Prizes: There are five (5) Holiday Chill Grand Prizes available to be won. Each Holiday Chill Grand Prize consists of a Chill in the City trip package for two (2) people, Grand Prize winner and one (1) guest (the "Guest"), to New York, NY on a date to be determined by Sponsor in February or March of 2027 (to be announced at the time of winner notification). Grand Prize trip package includes:

- Round-trip, coach-class air-transportation for Holiday Chill Grand Prize winner and Guest to New York, NY from a major airport within the 50 United States nearest the winner's residence as determined by Sponsor;
- Two (2) nights hotel accommodations based on a single room with double occupancy at a hotel of Sponsor's choice;
- Two (2) \$250 Chillhouse gift cards, one (1) for the winner and one (1) for the Guest;
- One (1) dinner for winner and Guest;
- One (1) gifting and entertainment package (contents/details to be determined by Sponsor); and
- One (1) spa service at Chillhouse Soho up to a maximum value of \$500 each for winner and Guest.

The ARV of Holiday Chill Grand Prize: \$3,900.

Summer Chill Grand Prize and Holiday Chill Grand Prize collectively referred to herein as "Grand Prize" or "Grand Prizes". The ARV may vary based upon dates of travel and point of departure. The difference between the ARV and actual value of the Grand Prize will not be awarded.

First Prizes: There are twenty-four (24) First Prizes available to be won, three (3) per Entry Period. Each Second Prize includes one (1) \$500 CVS, Target or Walmart digital gift card (one (1) of each brand to be awarded per Entry Period; brand awarded to each winner to be determined by Sponsor in its sole discretion). **The ARV of the First Prize: \$500 each.**

The total ARV of all prizes available to be won: \$51,000.

There is a limit of one (1) First Prize per person and one (1) Grand Prize per person. Odds of winning will depend upon the total number of eligible entries received.

RANDOM DRAWING: Random Drawings will be conducted by the Sweepstakes Administrator, an independent representative of the Sponsor, whose decisions are final.

First Prizes: The potential First Prize winners will be selected in a series of random drawings from among all eligible entries received within the corresponding Entry Period on or about the corresponding Random Drawing Date indicated in the Entry Periods & Drawings Schedule in the "Sweepstakes Entry Periods" section of these Official Rules.

The potential Summer Chill Grand Prize winners will be selected in a random drawing on or about **Monday, August 31, 2026** from among all eligible entries received during Entry Periods 1-4.

The potential Holiday Chill Grand Prize winners will be selected in a random drawing on or about **Sunday, January 31, 2027** from among all eligible entries received throughout the entire Sweepstakes Period.

WINNER NOTIFICATION & VERIFICATION: Potential Grand Prize winners will be notified via email and/or phone, and will be required to sign and return, within 48 hours of notification, an Affidavit of Eligibility, a Liability Waiver and where allowable, a Publicity Release and an IRS W-9 Form, if applicable (collectively, "the Releases"). These Releases will require winner to furnish their Social Security Number for the sole purpose of tax reporting, as required by law. Guest of winner will also be required to sign a Travel Companion Liability & Publicity Release. Noncompliance will result in disqualification and an alternate winner may be selected. Trip must be taken on dates specified or prize will be forfeited in its entirety.

Noncompliance will result in disqualification and an alternate winner may be selected. Prizes will be sent to the address on the entry form or new address provided via email within 4-6 weeks of winner being verified.

If a prize notification or prize is returned as undeliverable, or if winner is found to be ineligible or not in compliance with these Official Rules, that winner will be disqualified, and the prize may be awarded to an alternate winner in a separate random drawing. If Sponsor is unable to determine and verify a potential winner after repeated alternate drawings or if Sponsor fails to receive a sufficient number of entries to correspond to the number of prizes available to be awarded, Sponsor reserves the right to not award such prize(s).

Sponsor will, in its sole discretion, determine which airport is closest to the Grand Prize winner's home. In the event the Grand Prize winner's residence is close enough to New York, NY such that air transportation is deemed by Sponsor in its sole discretion to be unnecessary, the Sponsor reserves the right to substitute a \$500 travel stipend in lieu of air transportation.
